It is hereby resolved by the Town of Brant; Erie County, State of New York that:

DOG ENUMERATION FEES
RESOLUTION # 357

WHEREAS, The State of New York, Department of Agriculture, as of January 1, 2011 has transferred dog licensing to the local Government level,

WHEREAS, because the Town of Brant wants to ensure all Town of Brant dogs are licensed, the Town of Brant plans to conduct a Dog census in 2011.

WHEREAS, the Cost of the census shall be funded by enumeration fees as permitted by State law.

THEREFORE BE IT RESOLVED, the Town of Brant Board hereby establishes an enumeration fee of five dollars for each dog found to be unlicensed during the census, and it is further

RESOLVED, that the Brant Town Board understands that some owners may have recently acquired their dog. Owners of recently acquired dogs must have readily available proof of the date they took possession of the dog to present to the census taker. Newly acquired dogs over 4 months of age must be licensed by the next business day following when they took possession of the dog. Failure to license in a timely manner will result in an enumeration fee.

RESOLVED, that the Dog Control Officer is authorized and directed to publish two (2) notices in the local Pennysaver to notify residents of the upcoming census not more than 60 nor more than 30 days prior to the start of such census, thereby allowing all to acquire their license, avoiding the fee.
